ISTOXX® FACTSET AGEING POPULATION INDEX

Index description

The iSTOXX FactSet Thematic indices are comprised of companies from selected markets exposed to a defined set of themes: Ageing Population, Automation & Robotics, Digitalisation, Breakthrough Healthcare. These companies operate in business areas that actively participate in social, economic and environmental changes and drive long-term structural trends.

To be eligible, companies must derive 50% or more of their revenues from businesses that fall under respective themes. FactSet Revere data is used for a granular breakdown of the revenue sources of the companies in the screening process. This in turn allows enhanced precision in the thematic investment approach and in the selection of companies with substantial exposure to the targeted themes.




Supersector weighting (top 10)



Methodology

The index universe of the iSTOXX FactSet Ageing Population index is defined as all stocks from the STOXX Global Total Market index that derive more than 50% of their most recent total annual revenues from sectors linked to the Ageing Population business and which are classified as belonging to a defined set of developed and emerging countries

The companies in the index universe are screened for all of the following criteria:

- » Country classification: stocks classified as part of the eligible countries list
- » Minimum liquidity: 3-month average daily trading value (ADTV) greater than one million EUR
- » Minimum size: free-float market capitalization greater than 200 million EUR
- » Revenues: more than 50% of revenues generated within the sectors associated with the Ageing Population theme.

The index aims to have a minimum number of 80 constituents at each review

The index is reviewed annually in June.
